KCSI PRISON RAPE ELIMINATION ACT (PREA) Annual Report

2025

Introduction:

The Prison Rape Elimination Act (PREA) was enacted federally in effort to prevent and address incidents of sexual abuse in criminal justice facilities. This annual report covers all years that PREA policies and implementation of procedures became mandatory in the PA Department of Corrections contract facilities. Keystone Correctional Services, Inc (KCSI) is designed with wide open spaces rather than secluded rooms which allows for 24-hour monitoring of reentrants. Keystone has maintained top notch video surveillance capabilities with storage capabilities so investigators can access this video surveillance from past events more effectively. Staff is continually trained in how to respond to PREA allegations. In 2025 Keystone housed on more reentrants than ever and was able to effectively keep reentrants safe from sexual abuse and sexual harassment. All investigations were reported immediately and thoroughly investigated by a third-party investigator. The compiled data comes from information for PREA allegation incident reports as well as investigated outcomes and incident reviews. This report was approved by KCSI President/Owner, Terry L. Davis.
